The event organizer NB PAY FZCO, Dubai Silicon Oasis, DDP, Building A1, Dubai, UAE, Registration number DSO-FZCO-13633 (22/03/2022) represented by General Manager Yury Morozov, hereinafter referred to as the "**Organizer**", acting on the basis of the Charter, hereby makes this public offer to any individual or legal entity, as well as individual entrepreneurs (hereinafter referred to as the "**Participant**"), to conclude a contract for the provision of services for organizing and ensuring participation in the event "**INTERNATIONAL FINANCIAL CONGRESS OF BRICS PARTNER COUNTRIES.**" Please read this Agreement carefully, and if you do not agree with any provision of this Agreement, the Organizer suggests that you refrain from accepting this offer.

1. TERMS AND DEFINITIONS

Organizer or **Event Organizer** means NB PAY FZCO, Dubai Silicon Oasis, DDP, Building A1, Dubai, UAE, Registration number DSO-FZCO-13633 (22/03/2022);

Participant: A person who has filled out the registration form on the Organizer's website, selected and paid for a participation package, and sent their representatives to participate in the Event.

Participation Package: Fixed options for a set of services provided by the Organizer, specified in Appendix 1 to this Agreement.

Event: "INTERNATIONAL FINANCIAL CONGRESS OF BRICS PARTNER COUNTRIES."

Organizer's Website: <https://brics-pay.com/events>

Venue means April 18-20, 2025, Silk Road by Minyoun 5*, Samarkand, Uzbekistan.

Other terms and definitions may be used in this Agreement. In this case, the interpretation of such terms shall be made in accordance with the text of the Agreement. In the absence of an unambiguous interpretation of a term or definition in the text of the Agreement, it shall be interpreted according to the legislation of the UAE and subsequently by business customs.

1. AGREEMENT

1.1. The Sponsor undertakes to provide the Event Organizer with a one-time sum of money (sponsorship fee) in the amount and manner stipulated by this agreement, for the purpose of organizing and holding the event "**INTERNATIONAL FINANCIAL CONGRESS OF BRICS PARTNER COUNTRIES**".

2. GENERAL PROVISIONS

2.1. This Agreement is a public offer, that is, an offer by the Organizer to conclude a contract for the provision of services for organizing and ensuring participation in the event "INTERNATIONAL FINANCIAL CONGRESS OF BRICS PARTNER COUNTRIES" (hereinafter referred to as the "Agreement") on the terms specified below.

2.2. The unconditional acceptance (full and unreserved acceptance) of all terms of this Agreement is represented by the Participant filling out the registration form posted on the Organizer's website and paying for the Participation Package by any method offered on the Organizer's website in accordance with the terms specified in this Agreement and on the Organizer's Website.

2.3. The acceptance period for this Agreement is until April 18, 2025.

2.4. This Agreement consists of an accepted public offer and its integral parts, as well as appendices, regulations, provisions posted on the Organizer's website.

3. SUBJECT OF THE AGREEMENT

3.1. The Organizer undertakes to provide services for organizing and ensuring participation in the event "INTERNATIONAL FINANCIAL CONGRESS OF BRICS PARTNER COUNTRIES" for representatives of

the Participant in accordance with the conditions established by this Agreement; and the Participant undertakes to pay for these services in full and send their representatives to participate in the Event.

3.2. The full list of services provided by the Organizer is specified in Appendix 1 to this Agreement.

3.3. The cost of services provided by the Organizer is indicated on the Organizer's website <https://brics-pay.com/events>

3.4. Date and location of the Event: April 18 - 20, 2025, Silk Road by Minyoun 5*, Samarkand, Uzbekistan.

4. RIGHTS AND OBLIGATIONS OF THE PARTIES

4.1. The Participant has the right to participate in the Event by sending their representatives according to the terms provided in the Participation Package (Appendix No. 1 to this Agreement), chosen by them and paid for according to this Agreement.

4.2. The Participant has the right to refuse participation in the Event by notifying the Organizer while complying with paragraph 6.4 of this Agreement.

4.3. The Participant undertakes:

4.3.1. To comply with the regulations of the Event.

4.3.2. To pay for participation in the Event (Participation Package) within the timeframes and procedures established in this Agreement.

4.3.3. To notify the Organizer no later than 14 (fourteen) calendar days before the start of the Event about changes in personnel composition of their representatives sent to participate in it.

4.4. The Organizer undertakes:

4.4.1. To provide services according to this Agreement as specified in Appendix 1.

4.4.2. To assist Participants in conducting business meetings and negotiations and exchanging experiences by organizing relaxation areas and contacts at the Event venue.

4.4.3. In case of changes to Event conditions (date or location), to notify Participants by posting such changes on its website and/or via email at least 10 (ten) working days before it occurs.

4.5 The Organizer has rights:

4.5.1 To change date or location or program of holding an Event after notifying Participants at least 10 (ten) working days before it occurs.

4.5.2 To involve third parties for providing services under this Agreement while remaining responsible before Participants for fulfilling its obligations under this Agreement.

4.5.3 Not to fulfill obligations under this Agreement or deny access to Participants' representatives if funds have not been received into Organizers' account or their transfer has not been confirmed by payment order.

4.5.4 To refuse execution of this Agreement subject to compliance with provisions under paragraphs 6.7 or 6.8 herein.

5. PAYMENT PROCEDURE

5.1 The total cost of services provided by Organizer is determined based on types and quantities chosen by Participant from Participation Packages indicated in Appendix No. 1 to this Agreement and is fixed; VAT is not applicable due to application of a simplified taxation system by Organizer.

5.2 Payment for services under this Agreement shall be made by Participant on a condition of 100% prepayment through transferring funds into Organizer's account using one of methods indicated on Organizer's Website but no later than March 18, 2025.

5.3 Payment date shall be considered as date when funds are credited into Organizer's account.

6. RESPONSIBILITY OF THE PARTIES

6.1 The Parties are liable for non-fulfillment or improper fulfillment of obligations under this Agreement and undertake obligations to compensate each other losses within limits caused according to this Agreement; compensation does not exempt parties from fulfilling obligations assumed.

6.2 In case claims or lawsuits from third parties or authorized bodies arise against Organizer due to wrongful actions from Participant or its representatives, Participant undertakes to compensate damages within ten (10) working days upon notification.

6.3 Transfer by Participant all or some rights and obligations under this Agreement to third parties is allowed only with prior written consent from Organizer.

6.4 In case Participant refuses participation in Event Organizer has right to retain penalty from funds received from Participant as prepayment for services at:

6.4.1 Fifty percent (50%) from prepayment amount if Participant notified Organizer about refusal at least twenty-five (25) calendar days but no later than twenty (20) calendar days before Event date.

6.4.2 One hundred percent (100%) from prepayment amount if Participant failed to notify Organizer about refusal less than twenty (20) calendar days before Event date.

6.5 Organizer shall not retain penalty if refusal is related with change of Event date notified less than ten (10) working days prior.

6.6 If Participant did not attend Event due reasons beyond control from Organizer without timely notification pursuant to agreement terms, then no refund shall be made from funds received as prepayment for services provided.

6.7 Participant must notify Organizer about refusal via email at congress@brics-pay.com using official letterhead signed by authorized person with stamp attached PDF format indicating organization name along with names representatives participating including package name payment order number; original must also be sent via postal service address indicated above; date receipt notification will be considered date paper notification received by Organizer.

6.8 Refunds will be made within ten (10) calendar days upon receipt paper notification from participant regarding refusal via postal service delivery method.

6.9 If materials provided violate authors' rights third parties participant must resolve issues at own expense compensating damages caused third parties.

6.10 If Organizer refuses provide services under conditions agreement due reasons beyond participant control then full refund will be made back participant prepayment amount received previously.

7. DISPUTE RESOLUTION PROCEDURE

7.1 All disputes which may arise between parties regarding obligations under the agreement herein shall be resolved through negotiations; if consensus cannot be reached during negotiations, the dispute shall be submitted to resolution court jurisdictional authority accordingly.

8. FORCE MAJEURE

8.1 Neither party shall bear liability for full partial non-fulfillment obligations arising circumstances force majeure occurring during execution agreement such as natural disasters wars terrorist acts strikes quarantine blockades actions governmental authorized bodies regulatory acts directly preventing fulfillment obligations parties; upon occurrence such circumstances performance deadlines extended duration force majeure events.

8.2 Party experiencing impossibility fulfilling obligations must notify other party writing about occurrence force majeure circumstances anticipated duration thereof conclusion thereof; sufficient confirmation above-mentioned circumstances will consist certificates issued relevant authorized bodies.

8.3 If inability fully partially perform obligations one party due force majeure circumstances does not cease before commencement event either party has right terminate agreement herein.

9. TERM AND CONDITIONS OF AGREEMENT

9.1 This agreement comes into force upon acceptance participant remains effective until complete fulfillment obligations parties.

9.2 Acts rendered service pursuant agreement shall not require signatures parties.

10. FINAL PROVISIONS

10.1 All messages/notifications/documents sent between parties using postal service delivery method email addresses specified section 11 agreement considered official correspondence framework agreement having legal effect; date transmission corresponding

electronic message considered day message sent via email; date transmission corresponding message postal service considered day received addressee arrival message post office addressee.

10.2 Organizer reserves right change supplement conditions agreement; all changes published website organizer.

10.3 Participant may submit personal data relating specific individuals involved organization consent; organizer entitled process personal data solely purpose concluding executing agreement cases. Participant agrees purposes mentioned herein Organizer may disclose personal data partners involved organization event without additional consent participant. Organizer commits process personal data ensuring confidentiality security.

10.4 Parties obliged notify each other changes legal banking details no later than two (2) working days occurrence such event regarding phone numbers email addresses immediately.
